RULES AND REGULATIONS

NFDC-NFAI FILM CIRCLE

- 1. Please enclose two copies of I-Card size photographs, photo ID proof and address proof.
- 2. The membership fee may be paid by Bank Transfer / UPI / Cash.
- 3. The membership will be valid for a period of one year starting from April 2025 upto March 2026.
- 4. Payments made are non-refundable.
- 5. The decision to issue duplicate cards will depend on the merits of the case. Application for duplicate cards will be entertained only if accompanied with a remittance of Rs. 100/-
- 6. Footwear is strictly not allowed inside the Auditorium.
- 7. Eatables and water bottles are strictly not allowed inside the Auditorium.
- 8. Mobile phones should be kept on silent mode or switched off in Auditorium.
- 9. Please ensure timely arrival to avoid disturbance to other members. Entry would be restricted 30mins after the commencement of the film.
- 10. Parking of vehicles is allowed only in the place provided (behind the auditorium) and is available on a first-come, first-served basis.
- 11. Entry for guests (non-members) is subject to approval and a fee of ₹50/- per person
- 12.For ticketed screenings, a fee of ₹100/- per individual. (₹50/- for students with valid student ID proof) has to be paid. Entry is free for FCM members.
- 13. Screening schedules will be shared solely via email. If an email address isn't provided, members can acquire the program from the NFDC-NFAI.
- 14. The front row in the auditorium is reserved for NFDC-NFAl officials and invitees; therefore, it should not be occupied by other members.
- 15. Members are entitled to attend all Film Festivals and events **organized** by the NFDC-NFAI
- 16. The membership is non transferable.
