- Three orders each executed for “similar item” where executed value is not less than the amount equal to 30% of the estimated cost.
- The last date of order execution may fall in the above mentioned period

### **2. The Bidder / OEM should have executed project for supply and installation / commissioning of same or similar Category Products during preceding 3 financial years (i.e. Current year and three previous financial years) as on opening of bid, as per following criteria:**

- (i) Single order of at least 35% of estimated bid value; OR
- (ii) Two orders of at least 20% each of estimated bid value; OR
- (iii) Three orders of at least 15% each of estimated bid value.

### **3. To be eligible for award of contract, Bidder / OEM must possess following Certificates / Test Reports on the date of bid opening (to be uploaded with bid): Should meet the Quality management system as per ISO 9001:2015, ISO 14001:2015, and OHSAS 18001:2007 or ISO 45001: 2018, BIFMA membership, Green Pro Certificate (IGBC Compliance), AIOTA , SEFA, QCI Valid Assessment Report and the required product categories should be accessed as OEM by the QCI. 

  - **Revised Terms and Conditions**
1. Commercial Experience Eligibility Criteria:

    - Three orders each executed for “similar item” “**i.e. mobile storage compactors for storage of film reels**” where executed value is not less than the amount equal to 30% of the estimated cost.
  2. The Bidder / OEM should have executed project for supply and installation / commissioning of same or similar Category **i.e. mobile Storage Compactors for Storage of Film Reels** Products during preceding 3 financial years (i.e. Current year and three previous financial years) as on opening of bid, as per following criteria:
    - (i) Single order of at least 80% of estimated bid value; OR
    - (ii) Two orders of at least 50% each of estimated bid value; OR
    - (iii) Three orders of at least 40% each of estimated bid value.
  3.
